

ORDINANCE NO. 2008 - O - 109

BUSINESS LICENSES

Whereas, the Village of Hopkins Park is a home rule municipality, it does hereby adopt this ordinance pursuant an exercise of its home rule powers;

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees

of the Village of Hopkins Park, Kankakee County, Illinois, an Illinois home rule municipality, as

follows:

Section 1: Chapter 12 of the Municipal Code of the Village of Hopkins Park, Illinois,

of 1984, as amended, is hereby amended by the addition of Article X to be entitled "OTHER

BUSINESSES." Said Article X to provide as follows:

Article X – Other Businesses

Section 1: License Required. It shall be unlawful to conduct or engage in any of the

businesses hereinafter described without first having obtained a business license.

Section 2: Application and Fees. For each of the businesses listed below, there shall

be an annual Business License Fee as stated:

BUSINESS LICENSES

Applications for a license to carry on any of the above listed businesses shall be made in writing to the Village Clerk on the Village business license application form. The fee shall be

for a period of one year, or proportional part thereof, commencing May 1 and ending on April 30 of the following year. Any person who continues to engage in business and who fails to renew a business license on or before April 30th of the year shall be given a 30-day grace period and shall pay an additional \$10.00. Any such person who fails to renew during the grace period shall

thereafter be deemed in violation of this article. No license shall be issued without a prior

inspection by the Village Building Inspector or designee and no license shall issue unless the premises is in compliance with all applicable provisions of the Village Building Code.

Section 3: Penalty. Any person, firm or corporation violating any provision of this article shall be fined not less than \$10.00 nor more than \$200.00 for each offense, and each day shall constitute and be a separate offense for every day on which a violation shall continue.

Section 4: That this Ordinance shall be in full force and effect from and after its passage, approval and publication as required by law. The Village Clerk is hereby ordered to publish this Ordinance in pamphlet form.
