

**ORDINANCE NO. 2009 - O - 2009-2**  
**DIRECTOR OF ECONOMIC DEVELOPMENT**

**BE IT ORDAINED** by the President and the Board of Trustees of the Village of Hopkins Park, Kankakee County, Illinois, an Illinois home rule municipality, as follows:

**Section 1:** The Village does hereby establish the part time position of Director of

Economic Development. The Director shall consider issues related to economic development within the village and its planning area and shall seek to engage in activities to encourage and attract commercial and industrial businesses to locate within the Village. The Director shall report to the Mayor and carry out those activities as may be directed by the Mayor. The Director shall consider those matters regarding potential economic development as may be referred to him/her by the Village Board of Trustees and shall give recommendations and suggestions to the Mayor and Village Board on matters of potential economic development.

**Section 2:** The Director of Economic Development shall be appointed by the Mayor

with the advice and consent of the Board of Trustees. The Director shall be an at will employee of the Village whose services may be terminated by the Mayor at any time for any reason.

**Section 3:** The Director shall be paid a monthly salary of \$\_\_\_\_\_ for all

work performed. It is anticipated that the Director shall work the equivalent of four days per month on Village matters. The Director shall attend at least one Village Board meeting per

month to report to the Board. The Director shall receive reimbursement for travel on Village business at the IRS mileage rate provided that all travel to be reimbursed must be approved in advance by the Mayor.

**Section 4:** That this Ordinance shall be in full force and effect from and after its

passage, approval.
