**Mayor's Report- Mark A. Hodge****Mayor Hodge Discussed:**

Audit (s) letters will cost \$7,500.00; two audits need to be completed to fulfill grant requirements; Water Tower and Housing Rehab Grant.

Tires behind Village Hall are gone; EPA didn't have funding in budget, therefore, caused an 18 month delay in removal.

No meeting scheduled yet with Supervisor Miles to discuss water contract. Township hasn't paid bill in two months.

Township submitted a FOIA request for copies of all checks written to the VOHP from 2012 to present.

Mayors Dinner was very positive; United Way Representative was guest speaker discussing lots of new jobs coming to Kankakee County.

United Way has a new call center for domestic violence, dial 211 for help; number was tested by board member and it not working yet.

Mayor discussed EJ Water, RCAP and their Engineer working with the community to help resolve many of the water infrastructure issues, their Engineer will write the grant for funding for FREE.

Mayor attended a Dope to Hope meeting at KCC, in 2016 there were 26 opioid deaths and in 2017 there were 57 opioid deaths.

Discussed conversation she had with Herman & Kittle's (HKP) Regional Manager; about the availability of Tax Credit Funding available for HKP to purchase the property on Spinning Wheel Road and develop additional quality housing for our community.
